

Introduction

This policy outlines the procedures for issuing and collecting fees for training products and services provided by ABC Training and Consulting. It also details the circumstances under which course fee refunds may be applicable.

ABC Training and Consulting has approved state and/or federal government funding agreements for eligible students. This policy is written in alignment with the contractual obligations and guidelines established by each State Training Authority and the Federal Government.

For training fees not specified by Government Funding Bodies, ABC Training and Consulting's Senior Management will determine and implement fees at their discretion, where applicable.

Scope

This policy applies to all training products and services provided by ABC Training and Consulting. It serves to inform prospective students and employers about the associated financial details, including fees and refund procedures.

Statement

ABC Training and Consulting will adhere to and maintain Financial Standards National Vocational Education and Training Regulator (Outcome Standards for Registered Training Organisations) Instrument 2025. Including but not limited to Standard 2.1. VET students have access to clear and accurate information concerning the organisation, the relevant training product, and students are made aware of any changes that may affect them.

National Vocational Education and Training Regulator Act 2011, National Vocational Education and Training Regulator (Compliance Standards for NVR Registered Training Organisations and Fit and Proper Person Requirements) Instrument 2025. 18 Prepaid fee protection measures and 9 Issuance of AQF certification documentation, where an NVR registered training organisation has assessed a VET student as meeting the requirements of the training product in accordance with subsection (1), the organisation must ensure the

AQF certification documentation is issued to the VET student within 30 calendar days from the completion of the assessment, provided the VET student: has completed the AQF qualification or completed one or more units of an AQF qualification which they have subsequently withdrawn from; and has paid to the organisation all agreed fees associated with the training product.

Fee For Service (FFS)

1. Fee Paying Students

Fee For Service arrangement requires a student and/or Employer to pay for training as determined by ABC Training and Consulting's fees outlined in the Training Agreement at the time of engaging with ABC Training and Consulting as their Registered Training Organisation.

ABC Senior Management determines and implements the fees as stipulated on the ABC website for the Fee for Service arrangement. These fees can be amended depending on the student's circumstances in relation to concession or delivery and will be at the ABCs discretion.

1.1. Fees

ABC Training and Consulting's qualification fees are calculated at a dollar amount per unit of competency. An additional enrolment fee of \$300.00 may apply and be invoiced at the commencement of a unit of competency.

Students will not be charged for Units of Competency verified as a Credit Transfer. However, units of competency undertaken as Recognised Prior Learning will incur the standard unit fee.

GST does not apply to Vocational Education and Training course fees for the qualifications on ABC Training and Consulting's Scope and will not be listed on the invoice. For other revenue, in addition to VET courses, GST may be applied at the discretion of ABC Training and Consulting and identified on the invoice.

All Tax invoices are issued to Fee for Service students and detail the type of course fee, payment terms, and payment methods.

1.2. Additional Fees

ABC Training and Consulting may charge additional fees for the following circumstances:

- A replacement qualification certificate or statement of attainment is issued at \$50.00
- Additional visits to the workplace for training and/or assessment outside the agreed delivery schedule or contract terms may incur additional fees. These include, but are not limited to:
 - Visits that occur outside the nominal course duration, such as during approved extensions
 - Situations where the learner has not made reasonable attempts to demonstrate progression within the agreed timeframe
 - Reassessment visits due to learner non-engagement, cancellations, or insufficient evidence of competency
 - Employer- or learner-requested visits that fall outside the normal scheduling arrangement
 - Trainer and assessor travel time and mileage
 - Accommodation or meal allowances (if applicable)
 - Costs for rebooking, re-preparation, or adjusted scheduling
- Where additional visits are necessary due to delays or disengagement not caused by ABC Training and Consulting, the RTO reserves the right to charge these costs. All such fees will be communicated prior to the visit and invoiced separately.
- Placement of a student with an industry employer will incur a \$350.00 fee.
 - Additional associated costs relating to the training, delivery and resources for placement programs, will incur a maximum fee of \$300.00, regardless of their course being subsidised or not.
- Administration Fees of \$50.00 for overdue invoices.

ABC Training and Consulting may apply further administration fees of \$50.00 on overdue invoices where:

- The payer has made no effort to communicate with ABC Training and Consulting staff; and,
- The Invoice is 21 days passed the due date.
- Additional late fees of \$50.00 may apply where:
- the overdue invoice reaches 35 and 49 days overdue; and
- where Debt Collectors are instated.

1.3. Refunds and Cooling Off Periods

A standard cooling off period of 14 calendar days from date of enrolment will apply for all fee for service enrolments. Students will receive a refund, less the Enrolment Fee, where the request to cancel the course has been received in writing by ABC Training and Consulting within the 14 calendar day cooling off period. Where students have only paid the enrolment fee, no refund will be made.

A cooling off period of 5 calendar days applies for new units commenced. Students will receive a full refund of the unit fee paid where a request for cancellation has been received in writing within the 5 calendar day cooling off period for released units.

A student may request a refund for units of competency they have paid for, but not commenced. In these instances, the student will be refunded the full amount for pre-paid and non-commenced units. Where a student has paid for and commenced a unit and requested to cancel enrolment outside of the cooling off period, no refund will be paid.

2. Trainees and Apprentices

ABC Training and Consulting offers Traineeship and Apprenticeship study pathways for students who are permanent (full-time and part-time) employees in a suitable workplace. These pathways may attract State or Federal subsidies for the Employer which helps to offset the course of training. However, in most circumstances, a Student Contribution Fee will be charged as part of their training.

These Student Contribution Fees are often covered by the employer leaving the student with no out of pocket expenses. Some employers may require students to pay their own student contribution fees – this should be noted at the time of the employer completing the invoicing authority form.

Where training subsidies are applicable, Trainees and Apprentices (or employers) are provided with an outline of the Student Contribution Fees in which they are required to pay as part of their Traineeship prior to the commencement of their enrolment. The fees will be outlined in the ABC Training Agreement.

Student Contribution Fees for subsidised trainees and apprentices are invoiced and collected in accordance with the relevant State or Commonwealth Government contractual guidelines.

2.1. Fees

Fees and training subsidies for Traineeships and Apprenticeships vary between states/territories and are outlined under the specific states/territories. Students applying for a traineeship or apprenticeship will be provided detailed fee information and/or individual fee schedules prior to or at enrolment (depending on the relevant funding requirements and process).

Additional Fees may apply as stated in 1.2 Additional Fees.

Tax invoices will be issued where appropriate and detail the type of course fee, payment terms, and payment methods.

2.2. Refunds and Cooling Off Periods

In most cases Traineeships and Apprenticeships have a defined probationary period in which a student may choose to cancel their enrolment without penalty. This is detailed within the training contract and the student's training plan.

Refunds of Student Contribution Fees for Trainees and Apprentices will occur as follows:

- If a course is cancelled by ABC Training and Consulting, prior to the commencement date of the course, any Student Contribution Fees paid will be fully refunded.
- If the trainee/apprentice cancels their enrolment prior to the commencement date of the course and the Student Contribution Fees have been paid in advance, full refunds of fees will be made.
- Proportionate refunds of fees paid may be offered where a student withdraws from a unit of competency once training has commenced.

Please note: where Student Contribution Fees for Trainees and Apprentices were paid by the Employer, any applicable refunds will be provided directly to the employer.

Queensland (QLD)

3. Career Start and Career Boost

ABC Training and Consulting is a Skills Assured Supplier (SAS) as part of the QLD Subsidised Training through the Department of Trade, Employment and Training (DTET). Queensland residents may be eligible to access the subsidised training under Career Start and Career Boost programs as either general or apprenticeship/traineeship pathway.

Once eligibility is determined, eligible students accessing the subsidised training will have co-contribution fees calculated at a standard rate.

As stipulated in the *Skills Assure Supplier Policy 2025 - 2028, Appendix 1: Co-Contribution fee*, ABC Training and Consulting must collect the co-contribution fee on a unit of competency basis from the student, employer or a relevant third party. ABC Training and Consulting cannot pay or waive the fees (whether directly or indirectly) unless outlined in the relevant program policies or guidelines.

3.1. Special Terms

Career Start: An individual may access up to **two** subsidised training places through one of the following options:

- a general qualification at certificate III and an apprenticeship/traineeship, noting that if the apprenticeship/ traineeship is done first, the individual is no longer eligible to access a general qualification under Career Start; **or**
- two apprenticeships/traineeships at either certificate II or III, including school based apprenticeships or traineeships (SATs).

Career Boost: An eligible individual may access:

- one subsidised training place in either a certificate IV, diploma, or advanced diploma qualification under the general training pathway; **OR**
- a higher level apprenticeship/traineeship at certificate IV or above; and up to two subsidised skill sets in priority industries or sectors as part of the program.

If the individual has already accessed two apprenticeships/traineeships through a school based apprenticeship or traineeship (SAT) or Career Start within the last 10 years, they are not eligible to undertake an apprenticeship/traineeship under Career Boost.

Additional: Students can receive funding for only one apprenticeship or traineeship at a time. If two training contracts are registered at the same time, the contract with the earliest start date will qualify for funding, provided all other eligibility requirements are met.

Refusal: ABC Training and Consulting may only refuse to enrol or deliver training and assessment to an apprentice or trainee if one or more of the following conditions apply:

- The SAS has the Department's written consent not to enrol Apprentices/Trainees;
- The employer of the Apprentice/Trainee is a prohibited employer under the Act;
- The SAS is prevented pursuant to the Act from enrolling Apprentices/Trainees;
- A Co-contribution fee is not paid despite the SAS providing its fees policy prior to enrolment;

- The employer does not pay, or agree to pay, any additional SAS charges associated with the provision of training and assessment services.

General Pathway: Students who are accessing Career Start and Career Boost General Pathway must not be enrolled in any qualification (whether on hold or deferred) and must not have completed the same level qualification or higher within the last 10 years (whether funded by DTET or not)

3.2. Fees

Apprenticeship/Traineeship Pathway

Student Contribution fees are calculated at \$1.60 per nominal hour for each unit of competency as per the student's Training Plan. An invoice will be issued at commencement of training.

Partial Fee Exemption: Where concession is applied, the fees will be reduced to 40% per nominal hour for each unit of competency as per the student's Training Plan.

Fees and Refunds Policy

Concessional Status:

- Was or will be under 17 years of age at the end of February in the year in which the SAS provides training, and is not at school and has not completed year 12;
- Holds a Health Care, Veteran or Pensioner Concession Card issued under Commonwealth law, or is the partner or a dependant of a person who holds such a card and is named on the card;
- Holds an official form issued under Commonwealth law confirming that the individual, their partner or the person of whom they are a dependant, is entitled to concessions under a Health Care, Veteran or Pensioner Concession Card;
- Identifies as Aboriginal or Torres Strait Islander.

**To qualify for concession rates, the student must provide valid evidence at enrolment*

Full Fee Exemption: Where full exemption applies, student will not be charged any contribution fee. To qualify for a full exemption, the student must meet one or more of the following criteria

- Units of Competency with the outcome code 70 – Credit Transfer
- School based Apprentice or Trainee
- Undertaking a qualification as part of the Skilling Queenslanders for Work – Work Skills Traineeship program.
- Specific fee-free training programs as announced by the Queensland Government.

General Pathway

Student contribution fees for Career Start General are calculated at \$50.00 per unit of competency as per the student Training Plan. The co-contribution fee will be issued at the commencement of your units of competency.

Partial Fee Exemption: Where concession is applied, the fees will be reduced to \$25.00 per unit of competency as per the student's Training Plan.

**To qualify for concession rates, the student must provide valid evidence at enrolment*

Concession Status:

- Holds a Health Care, Veteran or Pensioner Concession Card issued under Commonwealth law, or is the partner or a dependant of a person who holds such a card and is named on the card;
- Holds an official form issued under Commonwealth law confirming that they, their partner, or the person of whom they are a dependant is entitled to concessions under a Health Care, Veteran or Pensioner Concession Card;
- Identifies as Aboriginal or Torres Strait Islander;
- Has a disability;
- Is an adult prisoner.

Full Fee Exemption: Students who meet the full exemption criteria will not be charged any co-contribution fees and therefore be entitled to fee free training. Students must meet one or more of the following:

- Specific fee-free training programs announced by the QLD Government
- Foundational Skills
- Undertaking a qualification as part of the Skilling Queenslanders for Work or VET in Schools
- Lower-level vocational qualification for concessional students as determined by ABC Training and Consulting.

Additional Fees may apply as stated in 1.2 Additional Fees.

Tax invoices will be issued and detail the type of course fee, payment terms, and payment methods.

3.3. Refunds and Cooling Off Period

Career Start and Career Boost

ABC Training and Consulting will refund contribution fees to the payee where a student has withdrawn and not commenced training in the unit of competency and where possible, apply proportionate refunds based on commenced and withdrawn units of competency.

New South Wales (NSW)

4. Entitlement Traineeships, Entitlement Full Qualifications & Targeted Priorities Full Qualifications

ABC Training and Consulting is an approved Smart and Skilled provider by the Department of Education through Training Services NSW to offer subsidised training to eligible students. Student contribution fees are listed on the ABC Training and Consulting website however actual fees will be calculated and provided to the student and/or employer prior to finalising the enrolment.

Student contribution fees are developed using the Smart and Skilled Provider Calculator on STS Online and are subject to change to indicate Recognised Prior Learning and Credit Transfers. Where applicable, ABC Training and Consulting will issue a refund or adjustment to the student and/or employer to reflect the update.

Furthermore, ABC Training and Consulting will:

- Notify students of any additional equipment costs prior to enrolment.
- Collect and retain Student Contribution fees
- Will not charge additional fees to approved Smart and Skilled students where sub-contracting arrangement are made by ABC Training and Consulting
- Ensure all Student contribution fees are paid in full prior to completion of training and assessment

ABC Training and Consulting do not charge prepaid fees more than \$1,500.00 however, will adhere to and maintain Financial Standards stipulated in the National Vocational Education and Training Regulator Act 2011, National Vocational Education and Training

Regulator (Compliance Standards for NVR Registered Training Organisations and Fit and Proper Person Requirements) Instrument 2025, 18 Prepaid fee protection measures.

4.1. Special Terms

Where a student does not complete a qualification at a certain level but has completed all requirements of a qualification at a lower level with lower Student Contribution Fees, ABC Training and Consulting will refund the difference of the Student Contribution Fees.

4.2. Fees

Entitlement Traineeships

As part of the NSW fee-free Traineeship Initiative, there is no student contribution fees for eligible Smart and Skilled Trainees who commence subsidised training on or after 1 January 2020 and meet the required eligibility.

Additional Fees may apply as stated in 1.2 Additional Fees.

Partial Fee Exemption: Where concession is applied, the fees will be reduced to a flat rate of \$240 per eligible student's Smart and Skilled qualification up to and including Certificate IV. There is no concession for Diploma and Advanced Diploma.

Concessional Status applies to:

- A student who is receiving a Commonwealth Government benefit or allowance at the time of enrolment or, is a named person on these cards for a partner or dependent.

**To qualify for concession rates, the student must provide valid evidence at enrolment*

Full Fee Exemption: Students who meet the full exemption criteria will not be charged any co-contribution fees and therefore be entitled to fee free training. Students must meet one or more of the following:

- An Aboriginal or Torres Strait Islander person
- A student with a disability
- A dependent child, spouse or partner of a recipient of a Disability Support Pension
- A refugee or asylum seeker (and eligible partners) – for training up to and including Certificate IV
- A recipient of a Fee-Free Scholarship - for training up to and including Certificate IV who meet additional eligibility criteria.

Additional Fees may apply as stated in 1.2 Additional Fees.

Tax invoices will be issued and detail the type of course fee, payment terms, and payment methods.

4.3. Refunds and Cooling Off Periods

Student contribution fees for all Smart and Skilled subsidised training will be processed as outlined below.

Withdrawal without Penalty

The Payee will receive a full refund of the Student Contribution Fees paid if they meet one or more of the following:

- ABC Training and Consulting cancel the student's enrolment
- Student and/or Employer cancels the enrolment prior to commencement of the course.
- Student and/or Employer cancels enrolment within 14 days of the commencement date, as outlined in the Fee For Service 1.3 Refunds and Cooling Off Periods of this document.

Student and/or Employer will receive partial refund where the student's enrolment is awarded Credit Transfers or completed Recognised Prior Learning.

Withdrawal with Penalty

The payee will not receive a refund of the Student Contribution Fee where they fail to meet the timeframes listed in Refunds and Cooling Off Periods of this document. If extenuating circumstances apply, Withdrawal with Penalty is obsolete.

Extenuating Circumstances

Partial refunds: Student Contribution Fees will be partially refunded for units of competency not completed where ABC Training and Consulting:

- Unable to deliver the agreed training or, cease operation or,
- The Smart and Skilled contract is revoked.

ABC Training and Consulting will follow the 6.9 Transferring Students of the Smart and Skilled Fee Administration Policy and Section 10, 10.1 Transferring Students of the Smart and Skilled Operating Guidelines. Students and/or employers will be notified accordingly.

Where a student does not complete a qualification at a certain level but has complete all requirements of a qualification at a lower level with lower Student Contribution Fees, ABC Training and Consulting will refund the difference of the Student Contribution Fee.

Australian Capital Territory (ACT)

5. User Choice (UC)

ABC Training and Consulting is an approved provider by the ACT Government, through Skills Canberra to offer subsidised training through the User Choice funding program. This program is available to eligible ACT students who are registered as an Australian Apprentice and have a training contract in place, completed through an approved Apprentice Connect Australian Provider (ACAP). Contribution fees for training are determined based on individual circumstances and will be calculated and provided to the student and/or their employer prior to commencement of training.

5.1. Special Terms

From 2022, a new Australian Apprentices directly employed by the ACT or Australian Government will no longer be eligible for User Choice funding.

User Choice subsidies will no longer be provided for existing workers undertaking training unless it relates to occupations identified on the ACT Skills Needs List, or sectors sustained by low-cost funding models (such as community services). Students classed as an Existing Worker and not subsidised, will be enrolled as Fee For Service.

5.2. Fees

The minimum Student Contribution fee for User Choice courses is \$600 and advertised on the ACT Public Register. Students, Employers or a related third party can pay the Student Contribution fee and, where a student is paying their Contribution Fee, the fee may be paid in one instalment or multiple.

Full Fee Exemption: Students who meet the full exemption criteria will not be charged any co-contribution fees and therefore be entitled to fee free training.

Full Fee Exemption applies to a subsidised Australian Apprentice who:

- Holds a valid Commonwealth issued health care card or pensioner concession card or, is a named person on these cards for a partner or dependent; or,
- Can prove genuine financial hardship.

**To qualify for full exemption, the student must provide valid evidence at enrolment*

Additional Fees may apply as stated in 1.2 Additional Fees.

Tax invoices will be issued and detail the type of course fee, payment terms, and payment methods.

5.3. Refunds and Cooling Off Periods

The Student Contribution Fees will be refunded to the appropriate payee where one of the following is met:

- ABC Training and Consulting cancels the course in which the student has enrolled.
- The student cancels their enrolment prior to the commencement date of their course.

Northern Territory (NT)

6. User Choice

ABC Training and Consulting is an approved provider by the Department of Industry, Tourism and Trade, through Business and Workforce to offer subsidised training under the User Choice funding program. This program is available to eligible NT students who are

registered as Trainees or Apprentices and have a training contract approved by an Apprenticeship Support Network (ASN).

6.1. Special Terms

Apprentices and trainees are excluded from accessing VET funding through RTOs if they are employed by a NT or Australian government agency or employed through a group training arrangement and hosted to a NT or Australian government agency or business division.

Students classified as an Existing worker may not be eligible to access subsidised training and therefore enrolled as Fee For Service.

6.2. Fees

Student Contribution fees are not applicable in NT for eligible trainees. Where a student is in-eligible for subsidised training, a Fee for Service arrangement will occur.

Additional Fees may apply as stated in 1.2 Additional Fees.

7. User Choice

ABC Training and Consulting is an approved provider by the Department of State Growth, Skills Tasmania to offer subsidised training under the User Choice funding program. This program is available to eligible TAS students who are registered as Trainees or Apprentices and have a training contract approved by an Apprentice Connect Australian Provider (ACAP).

7.1. Fees

The minimum Student Contribution fee for User Choice courses is \$800. Students, Employers or a related third party can pay the Student Contribution fee in full or on an agreed payment plan.

8. Funded Activities

ABC Training and Consulting are contracted under the Funded Activities Agreement (FAA) through Skills South Australia (SA) to deliver funded training. South Australian residents may be eligible to access the subsidised training through FAA as a Subsidised Traineeship and Apprenticeship, Priority Training, Local Skill Sets or VET for School Students.

As noted in the Funded Activities Agreement, Clause 21, Collection of Participant Course Fee, 20.1, Funding levels are premised on the principle of co-investment, i.e. in addition to the Funding, there will be a financial contribution for the Training in the form of a Participant Course Fee paid to the Recipient by the Participant, the employer of a Participant, or some other person or body. Hence, there is an expectation that the Recipient will charge a Participant Course Fee, unless otherwise specified by the Minister. The Participant Course Fee cannot be paid or waived by the Recipient.

The Participant Course Fee is calculated on a dollar amount set by Skills SA as the AQF Reduction and multiplied by the units of competencies nominal hours. Furthermore, any incidental fees may be charged as stated in 1.2 Additional Fees.

8.1. Fees

Eligible students Participant Course Fee (PCF) will be calculated per unit of competency nominal hour as per the students Training Plan.

The fee table lists the participant course fee calculated per qualification and stream that ABC Training deliver as either the Subsidised Traineeship and Apprenticeship List (STAL) or Training Priority List (TPL).
